CAPACITY BUILDING



The objectives of FMSF's programmes are:

- To undertake financial monitoring of the projects by developing close interaction with partner organizations & ensuring regular submission of financial & progress reports; by facilitating timely & regular transfer of funds to the projects as well as develop systems & procedures to ensure timely closure of projects.
- To enhance the organizational capacity of the partner organizations in the areas of financial management, legal compliance and related governance as well as develop good accountable practices.

1. FINANCIAL MONITORING

FMSF has been committed towards rendering services to BFTW and its partner organisations. One of the core areas of FMSF intervention is in the financial monitoring of BftW supported development projects. The overall objective of financial monitoring is to facilitate the development process by enhancing capacities of partner organizations and institutionalizing effective systems and processes. FMSF always emphasizes the need for improved project management standards in partner organisations, which would lead to greater accountability and transparent practices and thereby, enhance development effectiveness.

FMSF since its inception has been involved in the financial monitoring of development projects in South Asia, as one of its core activities. The regular monitoring function performed by FMSF includes projects supported by BFTW in South Asia viz. India, Bangladesh, Nepal and Sri Lanka. The financial monitoring function carried out by FMSF ensures that funds reach the partner organisations on time, the planned activities are smoothly implemented and partner organisations comply with the reporting requirements of BFTW.

FMSF pursues financial monitoring of BftW projects by:-

- Developing close interaction with partner organizations;
- Ensuring regular submission of financial & progress reports;
- Facilitating timely & regular transfer of funds to the projects;
- Developing systems & procedures to ensure timely closure of projects.

- Planning and Preparation of the Closure report





2. CAPACITY BUILDING

Capacity building of NGOs is one of the core areas of intervention of FMSF. FMSF aims to capacitate the partner organizations as well as other NGOs in the areas of financial management, internal control systems, governance and other related areas. FMSF strives to build capacities of NGOs and conducts various workshops. Apart from organizing and facilitating workshops, FMSF also undertakes capacity-building projects for partner organizations under CSR funding. Over the past 25 years, the capacity building initiative of FMSF has undergone changes. At present, FMSF endeavors to provide specific 'Application-based' capacity building support to partners.

FMSF follows a four-component intervention in its capacity-building framework.




FIGURE 1: FOUR COMPONENTS OF CAPACITY BUILDING

I. TRAININGS & WORKSHOPS

FMSF has conducted several workshops on topics of governance, financial management, budgeting, internal controls and legal compliances. These workshops are highly appreciated by the partner organisations. During the workshops, resource material is also provided to all the participants. The feedback of partner organisations on workshops has been very positive.

At the end of each workshop, a way forward/action plan is shared with the organisations. The methodology followed for the workshops is interactive and participatory. The capacity building programme addresses relevant issues for the NGOs.

IV. NETWORKS

NGO ACCOUNTANTS NETWORK (NAN) is a capacity building initiative of FMSF. This network was formed by FMSF with the objective of building a pool of expertise, creating mutual learning platform, and to capacitate the NGO Accountants on new tools and concepts for Financial Management. Accountants who are working with the NGOs are part of this network and are invited as and when this is organised. FMSF acts as a facilitator and resource organisation to the network.

In the midst of the changing regulations, it is imperative for the organisations to be oriented on the new compliance requirements. Furthermore, preparedness of the organisation to deal with increasing requirement also demands strengthening of its capacities. At the same time mutual learning and sharing of experience amongst NGO finance personnel also contributes towards organisational preparedness. During this period, a NAN (NGO Accountants Network) convention was organised in India where several organizations participated.

CREATING SCALABLE & REPLICABLE MODELS OF ACCOUNTABILITY IN NGO'S- PHASE II 2018-2019

Voluntary Organisations exist in and operate within a complex and dynamic web of cultural and political surrounding. social. economic, Primarily, organizations aspire to improve the lives of the poor and their focus remains on programme delivery. Secondly, since the incorporation laws for NPOs do not promote a structured evolution there is no external pressure to develop systems and processes. The major challenge for NGOs is the legal framework. The legal framework for NGOs is getting more and more complex by the day. Voluntary organisations have to be accountable to various stakeholders ranging from direct beneficiaries, government and donors (primary stakeholders) and other social organisations and society at large (secondary stakeholders). The challenge to demonstrate and enhance accountability is an ongoing requirement for an organisation. While looking at aspects about enhancing accountability, it is important to also look at the existing capacity of a voluntary organisation to support and face emerging new demands in the sector.

Given these circumstances, the logical response was to build capacity and establish scalable models of good governance and financial accountability for selected non-profit organisations in India. Therefore, a grant from Oracle funded the institutional capacity building of 30 non-profits in five states. This capacity building programme focused in the areas of financial management, governance, legal compliance, control systems, and operational excellence.

During the period April - March 2019, the following activities have been taken:

- 1. Need Assessment
- 2. Strategic Management Workshop
- 3. Mentoring & Guidance Support-I
- 4. Operational Management Workshop
- 5. Mentoring & Guidance Support-II
- 6. Impact Assessment
- 7. Accreditation & Certification

The organisational capacity enhancement programme focused on building capacities of 30 organisations in five states i.e. West Bengal, Jharkhand, Odisha, Chhattisgarh & Bihar. Initial registrations for about 80 organisations were received, out of which 30 organisations were shortlisted based on fulfilment of basic requirement of documents and selection criteria. These 30 organisations successfully completed the need assessment process and out of these only 27 organisations attended strategic management workshop i.e. the first two-step of the process. In order to reach the goal of 30 organisations, we once again made announcement for the program and enrolled 3 more organisations.

The need assessment was done for these 3 organisations and later given training on "Strategic Management" during the two day "Mentoring & Guiding Support" process. In total, 30 organizations were enrolled for the program.

Strategic Management Workshop:

FMSF conducted a two day Strategic Management Workshop for its partner organisations in NOIDA under "Organisational Capacity Enhancement Programme" (OCEP) 2018-19 supported by Oracle INDIA. The two day workshop was held on 24th & 25th July 2018 at Kolkata. Forty-nine participants from 27 organisations of five states namely West Bengal,

Jharkhand, Bihar, Odisha & Chhattisgarh participated.

Operational Management Workshop:

A two day Operational Management Workshop was organised for the partner organisations in NOIDA under "Organisational Capacity Enhancement Programme" (OCEP) 2018-19 supported by Oracle INDIA. The two day workshop was held on 15th & 16th November 2018 at Kolkata. Fifty participants from 30 organisations of five states participated. At the end of one year capacity building process only 28 organisations qualified for accreditation based on the due diligence process conducted. One organisation accredited under Platinum category, sixteen under Gold category and eleven under Silver category. All these organisations were issued certificates. The impact has been covered in print & electronic media i.e. Facebook live video has been actively uploaded and shared. Mass-mailers has been circulated to various groups and in networks of the partners located in the four states.
