



One of the core areas of FMSF intervention is in the financial monitoring of BftW supported development projects. The overall objective of financial monitoring is to facilitate the development process by enhancing capacities of partner organizations and institutionalizing effective systems and processes. FMSF always emphasizes the need for improved project management standards in partner organisations, which would lead to greater accountability and transparent practices and thereby, enhance development effectiveness.

FMSF since its inception has been involved in the financial monitoring of development projects in South Asia, as one of its core activities. The regular monitoring function performed by FMSF includes projects supported by BFTW in South Asia viz. India, Bangladesh, Nepal and Sri Lanka. The financial monitoring function carried out by FMSF ensures that funds reach the partner organisations on time, the planned activities are smoothly implemented and partner organisations comply with the reporting requirements of BFTW.

Capacity building of NGOs is one of the core areas of intervention of FMSF. FMSF aims to capacitate the partner organizations as well as other NGOs in the areas of financial management, internal control systems, governance and other related areas. FMSF strives to build capacities of NGOs and conducts various workshops. Apart from organizing and facilitating workshops, FMSF also undertakes capacity-building projects for partner organizations under CSR funding.



Over the past 25 years, the capacity building initiative of FMSF has undergone changes. At present, FMSF endeavors to provide specific 'Application-based' capacity building support to partners. FMSF follows a four-component intervention in its capacity-building framework:

- Training & Workshops
- Information Dissemination

- Research and Publication
- Networking

FMSF has conducted several workshops on topics of governance, financial management, budgeting, internal controls and legal compliances. These workshops are highly appreciated by the partner organisations. During the workshops, resource material is also provided to all the participants. The feedback of partner organisations on workshops has been very positive. At the end of each workshop, a way forward/action plan is shared with the organisations. The methodology followed for the workshops is interactive and participatory. The capacity building programme addresses relevant issues for the NGOs.

CREATING SCALABLE & REPLICABLE MODELS OF ACCOUNTABILITY IN NGO'S- PHASE III, 2019 - 20



OVERVIEW OF THE PROJECT

Creating Scalable & Replicable Models of Accountability in NGO's" Phase-III is the initiative of FMSF supported by Oracle Foundation. This program provides a unique opportunity for the NGO's in India to develop their Governance and Financial Management system. It is a one-year program, wherein every organization selected had to undergo two workshops focusing at "Strategic Management level" and "Operational Management level" in the areas of Governance, Financial Management and Legal Compliances.

This was followed by "Mentoring and Guiding Support", which span over a 6 months' period. At the end, those organizations, which successfully completed the program, were accredited by FMSF and Oracle India for a period of one year. During its third phase the organizational capacity enhancement program was focused on building capacities of 30 small and medium organizations in five states i.e. Andhra Pradesh, Telangana, Tamil Nadu, Karnataka and Kerala

Out of 30, total 26 organizations took active participation in all the process. At the end of oneyear capacity building process only 15 organizations qualified for accreditation based on the due diligence process conducted by CPA Services. The accreditation is given on three categories of rating i.e.

- Silver-Basic standards
- Gold-Desirable Standards
- Platinum- Advanced Standards

Three organizations were accredited under platinum category, six under Gold category and six under Silver category. All these organizations were issued certificate with the seal of CPA Services, FMSF and Oracle.


